Dear Majority Leader Schumer, Minority Leader McConnell, Speaker Johnson, and Minority Leader Jeffries:

As the 118<sup>th</sup> Congress draws to a close, millions of Americans are looking to you to provide relief from high and rising health care costs that are threatening the health and financial well-being of our nation's families, workers, employers, small businesses, and communities. Over the last two years, Congress has spent countless hours drafting, debating, and advancing bipartisan, commonsense legislation that could address some of our health care system's most obvious failings and take critical steps to ensure everyone in America has access to the high quality and affordable health care they deserve. But time is running out to get these policies across the finish line. We urge you to act before the December 20<sup>th</sup> government funding deadline to finish the job you started and advance pro-consumer reforms to the health care system that improve transparency, promote healthy competition, and curb industry abuses in order to lower health care costs for everyone.

Last year, the House of Representatives advanced the *Lower Costs, More Transparency Act,* which promoted meaningful transparency in pricing and billing, and advanced "same service, same price" payment reforms in an overwhelmingly bipartisan vote - but that legislation has yet to be considered in the Senate. Key committees in the House and Senate have also considered legislation to address anticompetitive behavior of drug corporations and to bring to light the harmful role of private equity ownership in health care - but those policies have yet to come to the floor for a vote. If enacted, these policies could set a critical foundation for reining in rising health care industry consolidation and the ability of medical monopolies to reduce competition and set unjustifiably high prices. These reforms would help reduce inflated health care spending and make health care more affordable and value-driven for consumers. But time is running out for the 118<sup>th</sup> Congress to act.

Therefore, we call on Congress to pass a robust health care package that improves health care affordability through policies to increase hospital and PBM pricing and billing transparency; "same service, same price" payment reforms; and prohibitions on anticompetitive contracting terms, among other key health system reforms.

As stewards of the federal budget and its many implications on our health care system, Congress must sometimes take difficult votes about the direction our country is steering - but a robust, well-vetted, bipartisan health care package that addresses our health care affordability crisis should not be one of them. The American people are with you. Consumers across the country are feeling the affordability crisis firsthand and want the government to act. Large majorities of voters support a range of policies to address consolidation and lower prices. Voters from both sides of the aisle broadly support:<sup>1</sup>

- Requiring hospitals to provide real prices in advance, not estimates (93%)
- Limiting outpatient fees to the same price charged by doctors in the community (85%)
- Preventing hospitals from engaging in business tactics that reduce competition (75%)

The American people are counting on you to take action before the end of the year, and the undersigned organizations implore you to act now. We stand ready to support you in this essential and urgently needed work.
